C. 2013/2014 ANNUAL BUDGET

a) 2013/2014 Annual Budget Debate

Secretary-Treasurer Laser directed Trustees to the packup and referred to the new Public Sector Accounting Standards. Secretary-Treasurer Laser advised that due to this new standard the Annual Budget Bylaw must include the budgeted expenditures in each of the funds; which include the operating fund, the special purpose fund and the capital fund. Secretary-Treasurer Laser provided an overview of each fund and stated that the budget Deliberations are about the operating budget only. There is an operating budget surplus of \$16,483. Since the 2104/2015 budget will start with a structural deficit in excess of \$8 million, the recommendation is to carry the \$16,483 forward to be applied against the deficit.

b) 2013/2014 Annual Budget Bylaw

8. NEW BUSINESS

A. Success by 6 Early Years Awards

District Principal of Learning Initiatives Janine Roy reported that the Success by 6 Early Years Awards recognize child and family services, businesses, programs and parks in our region based upon online survey feedback from parents and the community. This year the Greater Victoria School District #61 received two awards:

- Strong Start Centres received the award for "Favourite Child/Family Friendly Community Program".
- The Teachers and Principals of the Greater Victoria School District #61 received the award for "Individuals who made Children Feel most Respected and Welcome".

The awards were accepted on behalf of teachers and principals by Chair Orcherton at the Early Years Awards Ceremony on May 1, and Chair Orcherton conveyed congratulations to teachers, principals and Strong Start Leaders. The District shares these awards with Saanich (#63) and Sooke (#62) School Districts.

B. Reading Celebration Week

Campus View Elementary Principal David Hovis, Vice Principal Josee Paris, and teachers Katie Simmonds and Kelsey Anderson presented an overview of their Reading Week Celebrations. Activities were designed to promote reading engagement and achievement in English and/or French. A variety of classroom activities and whole school events were organized such as mystery reader contests, Reader's Theatre, author visits, book swaps and character dress up day. Reading Week involved members of the community and students' families. Two Campus View Elementary students shared how engaging and motivating the literacy-focused activities were.

C. Literacy Week

Lake Hill Elementary Vice Principal Cindy Harte presented an overview of Lake Hill's Literacy Week activities. Literacy Week provided engaging whole school, classroom and home-based activities. Community guests visited and shared their expertise, school district personnel read to students, friends and family members read with children, and professional authors and writers visited. In addition to special visitors, there were literacy-based events and activities, such as book browsing in the gym, a Reader's Theatre presentation by staff, posted book reviews and mystery guest readers. Literacy Week uses a different theme each year and family involvement is encouraged. Student feedback indicated that the favourite literacy activity was adults reading to students. A

Lake Hill Elementary student shared how much she enjoyed the events and recited a poem.

D. Battle of the Books

Monterey Middle School Teacher-Librarian Keely Thornton and Rockheights Middle School Teacher-Librarian Nicole Aerts presented Battle of the Books, a literacy-based tournament created by the Greater Victoria School District librarians. Teams from eight middle schools participated in the Book Battle this year, which involved participants reading six novels and competing in the full day Battle of the Books at Cedar Hill Middle School. Colquitz Middle School was this year's champion winning the round robin tournament.

Battle of the Books also involved a presentation by Bob Warren, former Vice Principal at George Jay Elementary, who created the "Read for the Top" program which is the model used for Battle of the Books. This locally-developed program is now also being implemented in schools in Kenya.

Students from Monterey Middle School and Gordon Head Middle School spoke about how Battle of the Books introduced them to different genres of books. The students expressed their desire to win the competition but were inspired by how it always remained good natured and fun regardless of the outcome.

E. Human Library Day

Spectrum Community School Vice Principal Sharoyne Gaiptman and Spectrum Teacher-Librarian Alan Clark presented an overview of Spectrum's annual Human Library Day. Human Library Day involves experts in various fields acting as 'human books' who are interviewed by students as a way to brainstorm ideas to promote environmental awareness and social justice. Spectrum Community School held their second full day event this year. Twenty-two experts in various fields acted as 'human books' as they were interviewed by over 300 students. A Spectrum student shared how her participation in Human Library Day encouraged her to continue with her chosen career path in medicine.

3. BUSINESS ARISING FROM MINUTES – None

4. PRESENTATIONS

A. Dr. Crofton and Dr. Blank – Electro-magnetic Radiation Exposure

Dr. Crofton presented information on Electro Magnetic radiation exposure. She expressed her desire for the Greater Victoria School District #61 to use the precautionary principle and to hardwire internet access where possible. Dr. Crofton expressed that this is a grey area and that not enough is known about the long term damage Wi-Fi exposure might cause.

Dr. Blank presented on electro-magnetic frequency (EMF). He explained that EMF is not normally felt until it is too late and damage has occurred. Dr. Blank spoke about the damage that EMF does to DNA causing DNA breakdown and genetic mutations to occur.

B. Katharina Gustavs – RF Meter

Ms. Gustavs presented information on installing Wi-Fi networks safely by placing access points away from students and staff, adjusting output power levels and installing an on/off switch. Any electronic device should be used as far away from the body as possible and tablets should have an Ethernet adapter.

C. Tammy Jeske

Ms. Jeske spoke about Health Canada Safety Code 6 and its irrelevance to Wi-Fi. Ms. Jeske was concerned that actual devices be used correctly, including all students reading the instructional pamphlets for the safe use of the device and the continual monitoring of how the device is used. Ms. Jeske explained that presently there are schools in BC that have decided to go wired and not use wireless.

Trustees asked questions and thanked the presenters.

5. FINANCE & LEGAL AFFAIRS

A. Sub-Committee on Public Engagement

Deputy Superintendent Bell provided an update on the Sub-Committee on Public Engagement. All four items that were referred to the committee have been discussed:

- Bylaw 9360
- Questions and Answers
- Speakers list
- Recording of Board meetings

A draft paper has been developed for each of the four items and the committee will communicate and make changes to the documents electronically over the next month. Once finalized the information will come back to the Operations, Policy and Planning Committee for

review as the Sub-Committee on Public Engagement provides input and ideas, it is not a decision making body. Deputy Superintendent Bell expressed her gratitude to the committee and expressed that they were a terrific group to work with. A report will most likely be presented in September.

6. FACILITIES PLANNING

A. Oak Bay Replacement Project Update

Mr. Howley, Director of Facilities and Jim Soles, Supervisor of Building Projects provided an update on the Oak Bay Replacement Project. The project is a design, build process as directed by the Ministry of Education that utilizes the services of a procurement manager.

The vision of Educators, Administration, Trustees, parents, staff and students were captured in a document called the Statement of Requirements. This document forms part of the proposal process and all requirements are being included as must haves.

Once a successful proponent has been approved from the shortlist of three teams Mr. Howley will provide more specific information. The successful proponent will be the lowest bid meeting all the requirements.

Construction will begin this coming July with the new school receiving students in September 2015 and project completion summer of 2016.

Mr. Howley thanked the Trustees and Superintendent Gaiptman for the tremendous amount of support Facilities has received.

Trustees thanked facilities staff for their work associated with this project.
