RE: DISPOSAL OF REAL PROPERTY BYLAW

PORTION OF LAND AT 3751 GRANGE ROAD (MARIGOLD/SPECTRUM)

The purpose of the June 28, 2016 Special Board meeting is to review the community feedback received at the Committee of the Whole meeting held earlier on June 28, 2016, to receive further input from the community and to vote on requesting Ministerial approval for the disposition of a portion of the 3751 Grange Road property.

The Board requires consent from the Ministry of Education to proceed with the disposition of the portion of the property located at 3751 Grange Road that will be dedicated to the public as a highway by the Ministry of Transportation and Infrastructure.

Recommended Motion:
