Coordinated Approach:

The District is acutely aware of the achievement gaps and lagging graduation rates among First Nations students. We have undertaken a coordinated approach among all learning departments to develop goals and strategies for improvement.

BC Ministry of Education How Are We Doing Report 2017-18:

Aboriginal Education Goals:

Aboriginal Education Goals are organized under four themes that encompass best practice and research.

- 1. Academic Achievement literacy, numeracy, attendance, retention, graduation
- 2. Belonging and Identity student perspective, voice and experience
- 3. Awareness and Understanding Aboriginal and non-Aboriginal shared history, culture
- 4. Relationship and Partnership close collaboration with local Nations and other partners

Moving Forward:

Current work to improve student outcomes includes targeted teacher professional development, new programs such as Grad Coach and Elders in Schools, and the development of Local Education Agreements with both Nations.

There have always been Indigenous peoples in the spaces we call home, and there always will be.

Territorial acknowledgements have existed for centuries as part of many Indigenous cultures. In recent years it has become common practice for organizations and individuals to acknowledge the land and the traditional custodians of the land at the beginning of gatherings.

1. Why is it important to acknowledge traditional territory?

- Acknowledging territory shows recognition and respect for the land and the traditional inhabitants of the land, both past and present. Recognition and respect are essential elements of establishing healthy, reciprocal relationships.
- Practicing acknowledgement can raise awareness of the history of the land and its first peoples that is often not well-known by non-Indigenous inhabitants.

2. Who should acknowledge traditional territory?

• The person giving the acknowledgment should be the person hosting or leading the gathering, regardless if they are Indigenous or non-Indigenous (acknowledgment of traditional territory is different than "welcoming" to territory, which would be done by local Nation leaders).

3. When is it appropriate to acknowledge traditional territory?

- It is appropriate to offer acknowledgment of traditional territory at large gatherings, events, assemblies, and meetings.
- Acknowledgement of territory can also be done in the classroom as a teaching tool or an inquiry. What do you know about the history of the land on which your school is located? What do you know about the local Nations? Why is land of such vital importance to Indigenous peoples?

4. How does one do an acknowledgement of traditional territory?

- The territorial acknowledgement should be done at the very beginning of the gathering (if you forget, just go ahead and acknowledge during the gathering!). SD61, in collaboration with the Songhees and Esquimalt Nations, has developed the acknowledgement statement that you see at the bottom of this page.
- The territorial acknowledgement should be approached not as an obligatory set of words to rush through in order to get on with the "real business", but rather approached in the spirit of good relationship and understood as an important part of the "business". The acknowledgement is also a call to give of our time and energy to learn and to build relationship.

Dear members of the Victoria Regional Transit Commission,

I am writing on behalf of the Board of Education of School District No. 61. I am writing to request the Commission's consideration of approving a new fare product to serve a number of students in our District. Recently, the Federal and Provincial governments and the First Nations Education Steering Committee came together to create a new transportation opportunity for First Nations students who live on reserve. The purpose of the plan is to have local school districts work with local nations to create local solutions on the issue of transportation. Currently, we are in the middle of our collaborative planning.

We know that attendance at school is a direct indicator of student achievement and access to transportation can impact school attendance. We have recently discussed with the local Nations the possibility of applying to the Commission to approve a new product that would provide a pass that would in effect act as a universal pass for all secondary school students that live on the Esquimalt and Songhees Nations. The pass would apply to slightly less than 70 First Nations students in grades 9-12 that attend mainly Esquimalt High, Spectrum, and Vic High. In discussions with the Nations they are completely supportive of such an exciting opportunity and will provide letters of support to move forward.

The District will collaborate with the Nations regarding the administration of such a pilot program. We thank you for your consideration and are happy to provide any additional information as required.

Transportation has been identified as a barrier to First Nations students' success in the public system. Under the New *BC Tripartite Education Agreement: Supporting First Nation Student Success* (BCTEA), Canada, BC and the First Nations Education Steering Committee have committed to ensure that First Nation Students living on-reserve get to and from BC Public Schools.

Songhees Nation and Greater Victoria School District are in the process of developing a joint First Nations Students Transportation Plan and have agreed to request to the commission the approval of a U-Pass system, similar to the University and College, for our secondary students who live on reserve. Songhees has approximately 40 students who attend the secondary public schools in the District.

Songhees Nation and the District will be working collaboratively with this initiative and supports the District's request to consider providing a U-Pass to secondary students who live on Songhees reserve.

My name is Trisha Chestnutt, and I am the Education and Programs Manager with Esquimalt Nation. I am writing on behalf of Esquimalt Nation in support of the Board of Education of School District 61, in regards to transportation for Indigenous students who attend Esquimalt High School and Victoria High School.

Our experience indicates that student attendance and transportation are directly linked. Students from Esquimalt Nation, who are in grades 9-12, require reliable, accessible and affordable transportation in order to attend school on a daily basis. We are in support of the development of a Universal Bus Pass for Indigenous students who live on Reserve on Esquimalt and Songhees lands.

We are thankful for the opportunity to support the Board of Education of School District 61 in the proposal to create a new universal bus pass that would support Indigenous students' transportation requirements.

7. FINANCE AND LEGAL AFFAIRS

A. 2018-2019 Amended Annual Budget

RE: Northridge Field

Background:

The first phase of the field drainage replacement of Northridge Elementary was tendered on June 27, 2018. The following bids were received:

- 1. Fusions Pipe Solutions for \$165,000.00 + tax
- 2. Socor Contracting for \$259,798.00 + tax
- 3. Victoria Drain Services for \$174,010.00 + tax

Both the low bid and middle bid were close to the engineer's estimate for the scope of work. After references had been called, a contract (purchase order) was created with Fusion Pipe Solutions. Fusion began the work on August 22nd.

While on site, the work by Fusion was very slow and of poor quality. The originally estimate of 3 weeks for the work took until October 26th to complete. Fusion employed the unusual pipe laying method of connecting the pipe above ground and rolling them into the trench. During field reviews, the engineer found many issues with the quality of work including improper grade, the wrong type/radius of connections, and poor headwall construction for the outfall. Additionally, Fusion damaged a sanitary sewer pipe that was marked on the plans, choosing to excavate through it rather than around it. Their repairs appear to be of poor quality and will be replaced at the School District's expense in the Spring.

After the trenches had been excavated, it was clear that the plan of using sand and clay mixed into the native soil as trench fill would not work. The native soil had a high clay content and would not have drained. Refilling the trenches with the clay would have "plugged" the field drain.

It was decided that all of the clay would be disposed of off-site and the trenches would be backfilled with a topsoil mixture that promoted drainage. We found a contractor to haul the spoil and Fusion coordinated importing the topsoil. These were separate costs not added to the original contract.

On two occasions, Fusion attempted to invoice for more than the progress on site indicated they were owed. Their initial invoice did not include a Builder's Lien Holdback, which was corrected on the next invoice. When trying to correct invoices, it often took up to a week to receive correspondence back from Fusion. Two holdbacks in addition to the Builder's Lien were agreed to with Fusion: \$5,173.41 for extra consulting fees incurred from the extended schedule and re-inspection of deficient items, as well as \$5,000.00 to cover the cost of having an OH&S specialist monitor the replacement of the asbestos concrete sanitary pipe that Fusion damaged, with remains of the \$5,000 to be returned to Fusion.

In December, we became aware that Fusion had balances owing to O'Dell Slinger and JS Excavating, two sub-contractors that they employed on the project. It was at this point, after negotiating holdbacks and establishing substantial completion with the contractor, that we stopped issuing payment. On February 7th, we received an email from Fusion's bonding company, Echelon Insurance, that they had received a claim from a supplier, Emco, against the Labour and Materials bond.

O'Dell and JS Excavating were in touch with Echelon, but they were outside of the bond and Builder's Lien holdback periods. After speaking with Heidi Khoe from Echelon, she agreed that the School District can pay those sub-contractors with the remaining contract funds owed to Fusion and the balance would be paid to Echelon to recover their losses.

Discussion:

As the field was left in less than desirable condition after the contractor left and did not return (and has since gone out of business), School District staff will remediate and build it back to a decent useable playing field. Staff will be starting within the next two weeks and will work through until they have it completed. Once completed, the field must remain closed for use so the Annual Rye and Fescue seed can take root and develop. To ensure strong root growth is established and firms up, common practise is to leave the field out of bounds for as close to a year as possible. During this time the area will be fenced off. It is our desire to make the field available to the school as soon as possible, considering the closure timeline.
