Dear Trustees,

Thank you for the opportunity to present to you on the topic of education funding on Monday night at the board meeting. Attached are our speeches and the slides for your reference.

Funding levels at \$1800/student less than the national average are harming public education. In our presentations, we urged you to speak up publicly in your co-governance role about improving education funding levels. We asked you to write urging investment in education to the Education and Finance Ministers and the Premier, and to instruct BCPSEA and the BCSTA that the contract language supports Victoria students.

Coincidentally, on Monday night the Vancouver School Board passed the following motion unanimously:

That we ask the provincial government to increase public education funding, specifically a significant increase to the per pupil amount, in order to better meet the needs of Vancouver students.

Victoria trustees have a disproportionate responsibility when it comes to advocacy for education funding. You govern a large district in the provincial capital - one that falls in the ridings of some of the most powerful members of the current government. We hope you will join the Vancouver School Board in acting publicly to call for an increase to education funding levels.

Education funding is lagging in BC

Education in BC is being harmed by a crisis of chronic underfunding. This impacts every single one of us here in this room. The trustee struggling to make good decisions about allocating insufficient funds, the superintendent trying to make magical organizational

decisions with those too-few funds, the teachers and EAs feeling overwhelmed by the impossibility of meeting the needs in their classes, and getting sick from the stress this causes, the parents frustrated that their children are not receiving the supports they need to thrive – all of this has the same genesis. A lack of funding investment in BC schools.





This slide shows us exactly how BC compares to the rest of the country when it comes to education funding. The green line shows how funding has remained relatively stable in the rest of the country over the past 18 years, the blue line shows BC. The orange line is operating grants pulled out – those are the funds that staff and provide learning resources in schools. It's clear BC has not recovered from the devastating cuts of 2002.

What if we funded education like we used to?



This slide shows how funding would differ if this NDP govt invested in education to the same level as the last NDP govt did. BC is currently touting itself as an international leader in education. It's hard to be a true leader when investment is so poor. Propping up the system and the stress of doing more with less is taking a toll on teachers. It can't go on like this indefinitely.

Education funding is lagging in BC



Here we see how BC's education funding compares to the rest of the country today. In real dollars, BC is well behind the national average - more than 1800 per student below. Not exactly leadership funding. In Victoria schools that's equivalent to a missing \$36,000,000 dollars from our annual budget. This is so shocking it seems almost unbelievable, but we've done our homework! And we can draw a straight line from this missing money to almost every issue we are facing as a district – whether it's lack of supports for our students with special needs, too few counsellors for students in crises, or how to adequately resource libraries.

But what about all the money?

You may have heard the story about the 'billion' dollars of new funding. Make no mistake, that money is desperately needed. But the figure doesn't tell the whole story. First of all, the billion is over three years – starting in 2017, prior to the NDP coming to power. Second of all – here's how it breaks down. 52% of it was returned to education after the court win that restored our language. It's money that was essentially stolen from the education budget every year for 16 years. 28% comes from per pupil funding due to increased enrollment. 17% is fulfilling previously negotiates salary increases – increases below inflation. Only 3% is new money – much of which is going to desperately needed infrastructure improvements, not much, if any is funding improved services to students.



Our system need investment in education to allow our kids to thrive. Teachers are trying to do their best to bring attention to this – but our voices alone won't be enough. We need to all be unafraid to tell the truth about what is really stopping us from helping our students reach their potential.

Trustees, you hold an important position. You have a co-governance role alongside the provincial government. You are in an equal partnership with government and if current levels of funding aren't working for you, it's your obligation to make that clear –to the BCSTA, BCPSEA and directly to the government. BCPSEA and the government have publicly stated, you are in charge. You need to make connections with trustees in other districts, you need to write to the ministers of education, finance and the premier, you need to instruct BCPSEA – and we need you to publicly amplify the message that our kids and our teachers are worth investing in.

How is education funding linked to bargaining?



No one wants this, right?

What's the role of the bargaining in preventing crowded, unteachable classrooms? Since the restoration of the stripped contract it's become clear that the contract ensures and funds smaller class sizes. When our class size and composition language was restored, you hired over 200 teachers in the first year. To show you concretely what I mean about class size, let's compare two real examples of staffing grids. Victoria has, in fact, benefitted more from the restoration of the contract than other districts around the province, due to what is called our 'superior' local class composition language. Here is a staffing grid from an English track middle school in Victoria. Note that although our class size limit is actually 29 – or 26 for a split class - classes are far smaller – an average of 22 students per class – due to the need for the district to make its best efforts to adhere to our class composition language.

We have heard from BCPSEA that smaller locals without language are doing just fine and in fact the flexibility to be able to organize grids in the way that best suits them is helpful for students. That's not true. Those districts did not receive the funding and the staffing that Victoria did. This slide shows one example - a school in Powell River. You can see the comparable intermediate grades are maxed out at 29. In Victoria, thanks to our excellent language, the government would provide funding to reorganize this school grid to add another classroom. The BCTF wants to bring everyone up to this level of staffing and funding in current bargaining.

What is the BCTF proposing for workload?

At the bargaining table the BCTF has been proposing a **baseline for class size and composition language** allowing districts to choose to opt into the provincial standard or maintain their own language. The idea here is that through subsequent rounds of bargaining, everyone would eventually come to the same place as the provincial language improved conditions over time. It's important to note that the BCTF is seeking to **modernize the language**. This is why a 'roll over' contract is unacceptable. We need to take the opportunity at the bargaining table to make changes that make sense and make conditions for students around the province better without making them worse for students here.

Underfunding is hurting BC's ability to provide an equitable opportunity to access education across the province. Currently there are hundreds of unfilled positions, and hundreds of uncertified adults teaching students in classrooms – especially, but not limited to, rural districts. In a province that aims to be an international standard for education, this can't be allowed to continue.

Additionally, BC is experiencing hundreds of what we call 'failures to fill.' In Langley alone they average over a hundred a week. What most often happens is learning support teachers, librarians and counsellors are reassigned to cover classrooms – taking extra support away from the kids who need it the most.

Teachers' salaries are way behind

If we are going to recruit teachers to the profession, we need to address the fact that teachers here are living in the most expensive communities in the country and have the second lowest wages in the country. Only Quebec teachers are paid worse. It takes a teacher at least 11 years to get to the top of the salary grid, even if they work full time.



BC teachers are:

- 9th out of 10 provinces for Category 5 starting salary
- 6th out of 10 for Category 5 maximum salary
- 7th out of 10 for Category 6 maximum salary

Trustees, if you believe in small class sizes, specialist teachers to provide support and that teachers need competitive wages to recruit and retain them in the profession, you need to say so. We have heard BCPSEA speak on your behalf, suggesting that Victoria students should give up teachers so that staffing can be standardized across the province. You need to tell them that is not what is best for our kids. Page 26 of 51

RE: Education Funding

The GVTA was pleased to see Trustee McNally's motion brought to Monday's Ed Policy meeting proposing a letter to government asking for a significant increase to education funding by increasing the per pupil amount.

Trustees know the difficulty of managing a district budget that consistently falls short of need, in the context of funding that lags \$1800/student behind the national average. An increase to funding could allow us to dream bigger here in the Greater Victoria School District – issues we have heard discussed at the board table include: better professional funding and in-service to improve teaching and learning, expanded school meal programs, additional counsellor supports for vulnerable students, more one-on-one direct instruction for struggling learners, adequate and equitable technology in music rooms, accessible play grounds in every school yard, drinkable water in classrooms, increased classroom collaboration with teacher-librarians, additional staff in schools of high need.

Although we expect our school trustees to engage in year-round advocacy, January is an ideal time to make a political statement about education funding, one month prior to the announcement of the provincial budget. We are concerned that the referral of the motion to the Advocacy Committee may mean the letter will be delayed past the time when it will have most impact. Should the Advocacy Committee not meet in time to bring a recommendation to the January Board Meeting, we urge the Board to deal directly with the motion at that meeting, to allow the Chair to write a timely letter.

RE: Speaking to Motions

At some point, the board adopted the practice of not allowing stakeholder representatives to speak once a motion has been put on the floor. We are concerned that this limits the ability of the stakeholders to provide meaningful input. It also prevents trustees from hearing the valuable insights from stakeholders into the issues they are considering. We are requesting that the board change this practice and allow stakeholders to speak once a motion has been put on the floor.

Allowing stakeholders to speak only before a motion requires the chair to remember to invite this before a trustee moves a motion. This not only requires an interruption to the order of speakers, but because it does not happen consistently, stakeholders are being prevented from speaking due to oversight and a 'technicality' that is an unnecessary invention.

When stakeholders speak before a motion, they do not know the rationale for the motion. Nor do they know if the mover intends to move the motion with alternate wording. If we are to provide meaningful or accurate comments, we must have the opportunity to hear the rationale for the motion first. Furthermore, allowing a stakeholder to speak before a motion gives them the first word in support or opposition to an idea that the mover hasn't yet been able to motivate.

Additionally, once a motion has been moved, there may be motions to amend, postpone or refer the topic. There are many situations where the stakeholders will have insight into the impacts of these subsequent decisions, that could not be anticipated before the motion was initially moved.

Presumably stakeholders have been invited to the table because trustees value their experience and insight, and there is no reason to arbitrarily refuse input simply because a motion has been moved. Robert's Rules already provides for limits to the number of times a speaker can speak to a motion, so creating this new rule only frustrates and shuts down input from stakeholders who have been invited to the table.

We look forward to your response in the matter.

Be it resolved that the BCSTA urge government to bring Early Childhood Learning and the appropriate full funding under the responsibility of the Ministry of Education.

From the ages 0 - 6 the human brain is highly sensitive to its environment. The brain sculpts and develops the basic competencies needed to thrive throughout life, such as emotional control, cognitive competencies, vision, hearing, symbol interpretation and language during this period.

The 2016 Early Development Instrument (EDI) results show the current provincial vulnerability rate for children vulnerable on one or more scales of development is 32.2%. This means about 1 in 3 children or about 14,000 students per year in BC are starting school with vulnerabilities in one or more areas that are critical to their healthy development. Additionally, research shows that child vulnerability in the province has meaningfully increased over the last decade. This level of vulnerability has significant social and economic cost, not simply as children start school but throughout their lives.

Children that grow up in caring, responsive, language rich environments with supportive adults are more likely to thrive in all aspects of their lives. The consequences of sub-optimal environments during this developmental period are serious. Literacy and numeracy skills, economic participation, criminality, and many adult health issues, including obesity, mental health (depression), heart disease, high blood pressure and non-insulin dependent diabetes, all have their roots in the early years (McCain, Mustard, and Shankar 2007).

Boards of Education have created beneficial relationships with early care and after school care providers across BC. Individually they have built partnerships within their districts, with community service providers; local health authorities; First Nations; and municipalities.

While BC's public schools face many challenges, bringing the responsibility for early care and learning under the Ministry of Education creates opportunities to strengthen public education through an integrated system of community based early care and learning programs which meet the needs of parents for quality child care and support school readiness for kindergarten,

Having recognized the impact quality early learning programming has to later life outcomes including; prosperity, health, and high risk behaviours, Ontario, New Brunswick, Prince Edward Island, Nova Scotia, Saskatchewan, Nunavut, Newfoundland and Labrador have all incorporated early learning and childcare into their Ministries of Education.

The Revised Early Learning Framework document is a positive guide for childcare programing and learning for children and families in BC however, licensed childcare programs are only required to meet Ministry of Children and Families health and safety standards – quality of program and instruction is not monitored and professional development opportunities are limited. Full equitable implementation province wide would benefit from the existing knowledge and expertise, administrative infrastructures and partnerships that of the Ministry of Education and its partners.

The Ministry of Education and Boards of Education are uniquely experienced in delivering, monitoring and adapting programs to ensure equitable quality learning opportunities which supports student success and life outcomes.

Opportunities of embracing early learning within the Ministry of Educations include;

- enhance the quality and accessibility of early care and learning programs by raising educational standards and remuneration for all early care providers;
- address specific community needs welcoming all children, including those with extra support needs or financial barriers;
- Offer play-based programs that are consistent with the BC Early Learning Framework, Aboriginal frameworks and pedagogical principles
- Connect families to resources and early intervention resources earlier in the child's development

 Improve EDI results, critical determinants of adult health, will result in a reduction of health care costs in the future

It is clear that the research supports an integrated early care and learning strategy. The Ministry of Education and Boards of Education are in a unique position to implement and oversee equitable, quality, accessible early learning and care by utilizing current infrastructures and local community relationships. By embracing early learning and early childcare under the responsibility of the Ministry of Education, Boards of Education will significantly improve the success of future BC students while supporting families.

3.3 The Policy must conform with the Province's Naming Privileges Policy, as amended from time to time.



4.0 RESPONSIBILITIES

4.1 **The Board of Education** is responsible to ensure compliance with the *School Ac*t.

4.2 **The Superintendent** is responsible to ensure that District policy is upheld and regulations are enforced.

REGULATION 1421

NAMING SCHOOL SITES

Adopted: February 27, 1995 Revised: 1. February 15, 2010, 2. May 28, 2018, 3. February 25, 2019 Frequency of Review: Annual

1. When naming a school site, the Board of Education of School District No. 61 (Greater Victoria) will appoint a committee to oversee consultation for the development of a suitable name. This will be done pursuant to Policy 1163 and Regulation 1163 – Consultation. The committee should include, at the minimum, the following:

a) A Trustee

- b) The Superintendent or their delegate
- c) The School Principal
- d) A member of the school's teaching staff
- e) A member of the school's Parent Advisory Council
- f) Up to 2 members of the Indigenous community
- g) Up to 3 members of the local community

2. The committee may request that the Board approve a specific name for a school site. The request must be accompanied by a report detailing the results of a consultative process carried out pursuant to Policy 1163 and Regulation 1163 – Consultation.

3. The committee must conform with the Province's Naming Privileges Policy, as amended from time to time.

Action:

Since George Jay is a RENAMING, which has choice in keeping or changing the name, and not a naming of a new site, in which case there is no choice as a school must have a name, it is preferable that the Board, after reviewing the George Jay Renaming Consultation Report (provided at the December 9, 2019 Operations Policy & Planning



Committee meeting) carry a resolution either advancing the name change process or retaining the current name.

If, based on the consultation report:

- the Board has **no desire to change the name**, then a committee should not be struck; **or**
- the Board wishes to **advance the name change**, then a committee should be struck.

If the committee is struck, it would be helpful for the Committee to have some guiding principles or values from the Board. Examples of values could be:

- Further consultation should be restricted to local catchment or Family of Schools catchments (greater Victoria versus school staffs and neighbourhood input)
- Student voice
- Reconciliation
- Indigenous naming
- Vancouver Island place based
- Learning focus
- Other?

Once the Committee has made its recommendation, the Board can debate the merits of the recommendation, and make a decision.
