1) Inclusive Education Working Group

- a. The Inclusive Education Working Group met at Provincial Council on February 21st and shared input from our Boards and staff. Of primary concern is tying into work of Inclusive Ed Committee while keeping focused on the mandate that AGM provided to us. We also discussed the provinces new Accessibility Framework and how that framework can be incorporated into working group efforts.
- b. Next steps: requesting more time and budget from BCSTA executive to meet in Vancouver with representatives from nonprofits involved in inclusive education. A list is being created of key stakeholders, including parent advocacy groups.

2) Presentation by Ministry of Education

- a. At Provincial Council we had presentation from Scott MacDonald, Deputy Minister in the Ministry of Education. I have provided trustees with hard copies of these PowerPoints. If members of the public would like to receive copies of these, please email the Ministry to request them.
- b. Of interest to Trustees, in Budget 2020 the Ministry of Education has cut it's operational budget by \$15m, or about 3% of additional funding over the 3 year fiscal plan.
- c. Capital funding over the next three years will be \$2.5 billion
- d. District funding has been increasing steadily since 2010, while the internal ministry budget has been decreasing, as a share of the overall budget.
