Note: Sign Fabricator requires: mathematical, spelling and reading comprehension skills as related to work assignments, basic computer knowledge, artistic aptitude; must possess a demonstrated knowledge of the standards, practices, methods, materials, tools and equipment used for the construction, repair and maintenance of buildings, grounds or equipment in his/her area of expertise; must have a valid BC driver's license; must have working knowledge of digital technology, including email, online databases and facilities management software used by School District #61; maintains a cooperative working relationship with other workers, administrators, supervisors, teaching staff, students, and the public; must be physically able to perform all duties as noted in the job description.</p>
