## **B.1 Board Motion: September 23, 2019**

That the Board of Education of School District No. 61 (Greater Victoria) direct the Superintendent, pursuant to Policy and Regulation 1421 and any applicable legislation, to establish a process and then a committee to explore changing the name of George Jay Elementary School.

### **B2.** Review of Provincial Naming Privileges

The Committee discussed the Provincial Naming Privileges and discussed that if the committee recommended to the board that they consider a change to the name, the cost of replacing uniforms, signs, stationary, etc should not be borne by the school.

The Committee also discussed Provincial Naming Privileges section 5. 4 with regards to giving consideration to the history or legacy of the current name and whether the existing name might be incorporated into the proposed new name, should the committee decide to recommend a change to the name.

## C.1 Update on the Equity Scan – Shelley Niemi

Phase two which involves the working groups interviewing partner groups would begin after Spring Break. Phase three is the data analysis. The committee asked when they can anticipate using the information from the Equity Scan to guide the work and Shelly suggested after Phase two.
