While the students will admit they are from a privileged background, they did represent different backgrounds, cultures and race. It is unfortunate that I could not offer them safety in this meetingand also recognize that the fear is real. They asked if they could submit anonymous written statements about their experience to be shared with the committee so that the student voice can still be heard. If not, I hope the power point presentation that was submitted can still be reviewed as it does have direct quotes from students, specifically around the self defense program and relationships with the liaison officers."
